

Yellowknife Speed Skating Club Waiver

****READ CAREFULLY. YOU ARE SIGNING AWAY LEGAL RIGHTS****

ASSUMPTION OF RISKS

I understand and appreciate that there are certain risks, dangers and hazards which are inherent in participating in speed skating activities. By signing this Waiver, I acknowledge that I am the legal guardian of the child whose name is listed below ("Child"), and I have the legal ability and authority to sign this Waiver on behalf of the Child. I acknowledge that the Child's participation in any speed skating activities involves certain inherent risks, dangers and hazards including, but not limited to:

- (i) possible collisions with objects, other skaters or coaches,
- (ii) injuries arising from the inherent physical nature of speed skating,
- (iii) injuries arising from the use of equipment;
- (iv) hazards related to the characteristics of the venue,
- (v) equipment failure, and
- (vi) acts, omissions or negligence of any person, including the Child.

By signing this Waiver I agree to assume these risks and all consequences that may flow from them on behalf of the Child. Further, I confirm that I am not aware of any medical condition(s) which should prevent the Child from taking part in any speed skating activities.

RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND INDEMNITY

In consideration of the acceptance of the Child's registration, I hereby agree, on behalf of the Child and the Child's executors, administrators, and assigns, as follows:

1. To release the Yellowknife Speed Skating Club (the Club), the NWT Amateur Speed Skating Association (NWTASSA), and Speed Skating Canada (SSC) or any of them, and their respective landlords, employees, volunteers, coaches, officers and directors from any and all liability for any loss, damage, expense or injury (including death) that the Child may suffer as a result of the Child's participation in any speed skating activity organized by the Club, NWTASSA, and SSC, or any of them, due to any cause whatsoever.
2. To waive any and all claims that the Child or I have, or may in the future have, however arising, against the Club, NWTASSA, and SSC, or any of them, or their respective landlords, employees, volunteers, coaches, officers or directors, with respect to the Child's participation in any speed skating activity organized by the Club, NWTASSA, and SSC, or any of them.
3. To hold harmless and indemnify the Club, NWTASSA, and SSC, or any of them and their respective landlords, partners, employees, volunteers, coaches, officers and directors from any and all liability, costs, expenses or damages (whether to person or property), of any kind or nature whatsoever, that they might suffer or incur arising out of or in any way related to the Child's participation in any speed skating activity organized by the Club, NWTASSA, and SSC or any of them.
4. In signing this Waiver, I am not relying on any oral, written or other representations made by the Club, NWTASSA, and SSC, or any of them and their respective landlords, partners, employees, volunteers, coaches, officers and directors, and this Waiver contains the entire agreement between myself and the Club.
5. In signing this Waiver, I grant permission to the club to use photographs and videos of my child/children on any club materials.
6. In signing this Waiver, I grant permission to the club to send me speed skating related email messages. This would include such things as schedule changes, upcoming events, and other club news. Our primary means of communication is via e-mail. Due to the anti spam law, you must inform the Club in writing if you do not wish to receive speed skating related email messages.
